**Güzin Bayraksan** (“Assessing Solution Quality in Stochastic Programs via Sampling”) is an assistant professor of systems and industrial engineering at the University of Arizona. She holds a B.S. degree in industrial engineering from Boğaziçi University and M.S. and Ph.D. degrees in operations research and industrial engineering from the University of Texas at Austin. Her research focuses on stochastic optimization, particularly simulation-based approximations in stochastic programming with applications in scheduling and water resources management.

**Oded Berman** (“Modeling Competitive Facility Location Problems: New Approaches and Results”) is the endowed Sydney Cooper Chair in Business and Technology and the former Associate Dean of Programs at the Joseph L. Rotman School of Management at the University of Toronto. He received his Ph.D. in operations research from the Massachusetts Institute of Technology. He has published over 190 articles and has contributed to several books in his field. His main research interests include operations management in the service industry, location theory, network models, and stochastic inventory control. He is an associate editor for *Management Science* and *Transportation Science*, and a member of the editorial board for *Computers and Operations Research*.

**James H. Bookbinder** (“Logistics and Transportation in Global Supply Chains: Review, Critique, and Prospects”) is a professor of management sciences at the University of Waterloo (UW), and Director of WATMIMS, UW’s research group in logistics and manufacturing. He served for 10 years as an associate editor of *Operations Research* (“OR Practice”), and has been an associate editor of *Naval Research Logistics* since 1992. He is a past president of CORS (Canadian Operational Research Society). He has edited a special issue on “Global Logistics” for *Transportation Research E* (Vol. 41, No. 6, 2005).

**Margaret L. Brandeau** (“OR’s Next Top Model: Decision Models for Infectious Disease Control”) is a professor of management science and engineering and a professor of medicine (by courtesy) at Stanford University. She is an operations researcher with an extensive background in the development of applied mathematical and economic models. She has worked in the areas of HIV, infectious disease control, and bioterrorism preparedness. She was awarded a Presidential Young Investigator Award from the National Science Foundation, the Pierskalla Prize from INFORMS, and the President’s Award from INFORMS.

**Tammy Drezner** (“Modeling Competitive Facility Location Problems: New Approaches and Results”) received her B.A. from McMaster University, Canada and her master’s and Ph.D. degrees from the University of Michigan. Her research interests are in the location of retail facilities, consumer behavior, and disaster planning. She has published over 40 papers in peer-reviewed journals such as *Naval Research Logistics*, *European Journal of Operational Research*, *Journal of Retailing*, *Journal of Regional Science*, *Environment and Planning*, and others, and has contributed to several books and encyclopedias.

**Zvi Drezner** (“Modeling Competitive Facility Location Problems: New Approaches and Results”) received his B.Sc. in mathematics and Ph.D. in computer science from the Technion, Israel Institute of Technology. His research interests are in location theory, metaheuristics, computer networks, and computational statistics. He edited two books and published

over 240 articles in refereed journals such as *Operations Research*, *Management Science*, *IIE Transactions*, *Naval Research Logistics*, and others.

**Thomas R. Jefferson** (“Geometric Programming”) is Director of the Optimal Duality Institute. He holds a B.Sc. in mathematics and an M.Sc. in statistics from the University of Toronto, and has a Ph.D. in management science from Northwestern University. He has held professorships at the University of Montreal; University of New South Wales; University of Waterloo; University of Pittsburgh; Tulane University; Hong Kong University of Science and Technology; Bilkent University; University of California, Los Angeles; and University of California, Irvine. He is a member of INFORMS. He has published over 80 scholarly articles.

**L. Robin Keller** (“Multiple-Objective Decision Analysis Involving Multiple Stakeholds”) is a professor of operations and decision technologies in the Paul Merage School of Business at the University of California, Irvine. She earned her Ph.D., M.B.A., and B.A. degrees from University of California, Los Angeles. Her decision analysis research focuses on multiple-objective decisions with environmental and health outcomes. She is Editor-in-Chief of *Decision Analysis*, a past president of the Decision Analysis Society of INFORMS, an INFORMS Fellow, and Kimball Medalist.

**Dmitry Krass** (“Modeling Competitive Facility Location Problems: New Approaches and Results”) is a professor of operations management and statistics at the Joseph L. He is also the director of the Ph.D. program in operations management at the Rotman School. **Elisa F. Long** (“OR’s Next Top Model: Decision Models for Infectious Disease Control”) is an assistant professor of operations management at the Yale School of Management. She received a B.S. in operations research and industrial engineering from Cornell University and a Ph.D. in management science and engineering from Stanford University. Her research interests include mathematically modeling the HIV/AIDS epidemic in resource-limited settings and evaluating the cost-effectiveness of medical interventions. He then joined the Operations Research Department at the Naval Postgraduate School as a National Research Council Postdoctoral Fellow. He is now an Engineering Foundation Professor in the graduate program in operations research at the University of Texas at Austin. His research interests include computational stochastic optimization, Monte Carlo approximations for stochastic programs, and interdiction modeling.

**Katta G. Murty** (“New Sphere Methods for Linear Programs”) is a professor of industrial and operations engineering at the University of Michigan, Ann Arbor. He received an M.S. in statistics from the Indian Statistical Institute in 1957, and a Ph.D. in operations research (OR) from the University of California, Berkeley, in 1968. His research interests are in OR and its applications to complex real-world decision making problems, and in studying human impacts on nature. His recent research contributions are in fast-descent algorithms (called sphere methods) for linear programming using matrix inversion operations sparingly, and in extending these sphere methods to quadratic programming and 0–1 integer programming.

**Carlton H. Scott** (“Geometric Programming”) is a professor of operations and decision technologies at the Paul Merage School of Business, University of California, Irvine. His research interests are primarily in the theory and applications of nonlinear optimization with a speciality in conjugate duality and geometric programming. His doctoral studies were in theoretical physics at the University of New South Wales in Australia. He subsequently worked as an operations research analyst for BHP Billiton on nonlinear optimization problems in the steel industry.

**Jay Simon** (“Multiple-Objective Decision Analysis Involving Multiple Stakeholders”) is an assistant professor of decision science in the Defense Resource Management Institute at the Naval Postgraduate School. His main research focus is multiattribute preference modeling, particularly involving outcomes that occur over time, space, or groups of people. Terlaky received his Ph.D. from Eötvös University, Hungary.
